Quota

All fencers, teams, coaches and referees must be in possession of an EFC licence (fee of 25 EURO) and entered at the EFC website by their respective National Federation respecting the mentioned deadline policy. Entering the fencer, coach or referee after the deadline is sanctioned by a penalty: for a fencer or coach 50 EUR per person, for a referee 100 EUR per person. (See EFC Administrative Rules, point 1.6 - <https://www.eurofencing.info/getFile/case:show/id:495398> )

A valid DFB fencing pass is a starting requirement for German fencers, referees and coaches. Adolescents under the age of 18 need a health certificate (not older than 365 days).

**Quota** The order of the incoming entries decides about the participation.

Referees must be provided based on the total entries per day.

The referees activity is not paid by the organizer.

We expect an adequate appearance:

- Trouser suit or skirt
- Suit and tie

a) The referees officiating at EFC Circuits should have a valid EFC-C / FIE B/A qualification. In a transitional phase a good national qualification can be accepted.

b) Minimum age of the referee must be 18 years and maximum 60.

d) In order to respect the quota delegations may "hire" referees from different countries. In any case this must be coordinated with the organiser and the EFC in order to guarantee that enough countries are represented within the referees.

**Image / TV rights**

TV, internet and radio rights to FIE, EFC tournaments and German Championships held in Germany are the responsibility of the German Fencing Federation (DFB).  
The use of these rights may be transferred to the organising club. Regardless of this, the fencing matches must be streamed on the DFB's YouTube channel.

The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.

**Medical**

A doctor is present in the competition site.  
Only doctors are entitled according to the international statutes to grant medical breaks during the fights.

All participants are required to check prior to the event to see if any more extensive EFC or state regulations have not been implemented.

**Equipment**

Equipment according to definition FIE and EFC.  
Furthermore, German safety standards apply.
