The number of participants is unlimited.

All fencers, teams, coaches and referees must be in possession of an EFC licence (fee of 25 EURO) and entered at the EFC website by their respective National Federation respecting the mentioned deadline policy. Entering the fencer, coach or referee after the deadline is sanctioned by a penalty: for a fencer or coach 50 EUR per person, for a referee 100 EUR per person. (See EFC Administrative Rules, point 1.6 - <https://www.eurofencing.info/getFile/case:show/id:495398>)

A valid DFB fencing pass is a starting requirement for German fencers, referees and coaches. Adolescents under the age of 18 need a health certificate (not older than 365 days).

The referees officiating circuit should have DFB CN licence and an annual license, good national or international level qualification and be aged minimum 18 and less than 60.

Format First round + direct elimination

The initial ranking of fencers is to apply as follows:

Current FIE ranking

EFC U23 Circuit ranking +1000

The places of non-ranked fencers are drawn randomly.

Registrations must reflect realistic participation! Free cancellation – with or without a medical certificate – is only possible until the rounds are scheduled. After that, the fee must be paid in all cases (even with a medical certificate), and in the event of a non-participation without a cancellation + medical certificate, a penalty fee of EUR 500 must be paid.

The certificate must be presented on the day of the tournament. In exceptional cases, it may be submitted by 12 noon on the following Monday.

The rounds will be published the day before the tournament by 5 p.m. at the latest.

All fencers will go to their assigned piste 10 minutes prior the start of the competition.

Continuation on Sunday with the best 64.

The tournament organiser reserves the right to alter schedules, taking into account the number of fencers.

Rules and legal

The competition is held on the basis of the rules and regulations of the FIE and the EFC.

The award ceremony will be held in the following outfit:

- Club tracksuit = Jacket or Shirt and long trousers

Liability	Organizer assume no liability. All participants are responsible for the personal equipment.
Jurisdiction	The participants submit to the jurisdiction of the FIE, EFC and the relevant national federation.
Anti Doping	Doping controls will be carried out. The DFB / Organiser is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organiser is proven to have acted with intent or gross negligence.
Image / TV rights	TV, internet and radio rights to FIE, EFC tournaments and German Championships held in Germany are the responsibility of the German Fencing Federation (DFB). The use of these rights may be transferred to the organising club. Regardless of this, the fencing matches must be streamed on the DFB's YouTube channel. The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition data. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.
Medical	A doctor is present in the competition site. Only doctors are entitled according to the international statutes to grant medical breaks during the fights. All participants are required to check prior to the event to see if any more extensive EFC or state regulations have not been implemented.
Equipment	Equipment according to definition FIE and EFC. Furthermore, German safety standards apply. Remarks	Venue may only be entered with sneakers. To participate, the participation fee must be paid in advance of the tournament's start (by bank transfer or in cash at the venue on Friday evening or Saturday morning).





Referees must be provided free of charge and must be registered by name in advance. Only full attendance on Saturday guarantees the planned schedule with the large number of participants in the competition.

The compulsory referees must be present on both days of the tournament for men's épée and women's épée and must attend the referees' meeting on each day.
